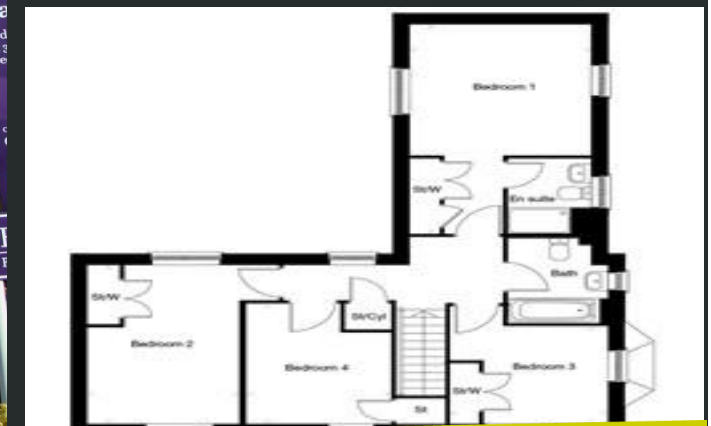
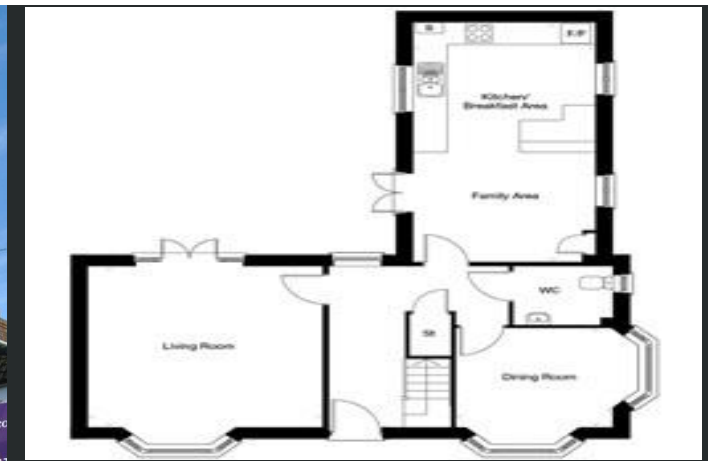


A traditional double-fronted home is well suited to families.
